

### 1 April

Displaced farmers from Cambodia filed a landmark class-action lawsuit in a Thai civil court against MitrPhol.

Violent forced evictions, burning of homes, looting of crops and livestock and the seizure of land





Such a ruling would also encourage the Thai government to take its extraterritorial human rights obligations seriously and sanction Thai companies that commit abuses overseas.

"We filed this lawsuit because MP took our land, our harvest, our access to the forest, and our children's opportunities to go to school," said one of the affected community members, who requested anonymity due to threats to her safety.

## May 2016 Cabinet Resolution on ETO

- The May 2016 resolution provides guidelines for how Thai investors who operate international businesses should adopt and comply with the <a href="UNGP">UNGP</a> and the "protect, respect and remedy" framework for business and human rights.
- Ministries of Justice, Commerce, and Foreign Affairs
- Significant policy development for those who face human rights abuses by Thai investors and their mega projects in Myanmar and the Mekong Region (such as SEZs, dams, and coal projects).



# Conclusion from field inquiry and investigations



- Led to extra-territorial obligations (ETOs) in Cabinet Resolution and NAP
- Law needs to be enacted to regulate Thai investments abroad
- Lack of enforcement& implementation

### **ETO Watch Coalition calls for:**



- The Thai government to take concrete steps to monitor, prevent, investigate, and redress human rights abuses by Thai investors, and
- To enforce stronger regulations for activities of Thai investors abroad, including around projects with transboundary impacts.

## Challenges to Transboundary Accountability & Recommendation



- Access to effective remedy is very limited
- Role of NHRI in cross border investigation
- Address potential transboundary impacts in impact assessment processes with inclusive participation from affected communities. Lack of law requirements.
- State's role to monitor Thai investors and establish an effective mechanism to enforce extraterritorial corporate responsibility.
- Ensure development financing and HR compliance of outbound investments
